**MOTION FOR ISSUANCE OF SUBPOENAS DUCES TECUM**

The undersigned, on behalf of APOC Staff, hereby moves for the issuance of subpoenas duces tecum in this case, pursuant to AS 44.62.440(a). APOC Staff is conducting investigation into whether the respondents in this matter have engaged in or about to engage in an act or practice that constitutes or will constitute a violation of AS 15.13 or a regulation adopted under AS 15.13. Specifically, Staff has delivered to Erim Canligil, Treasurer of A Stronger Alaska and Chief Financial Officer of Republican Governor’s Association, and Dave Rexrode, Chair of A Stronger Alaska and Executive Director of Republican Governor’s Association, requests for information and documents pursuant to AS 15.13.045(c). In response to those requests, counsel for A Stronger Alaska and Republican Governor’s Association have refused to respond to Staff’s request unless a subpoena is issued pursuant to AS 15.13.045(d).
